**Yearbooks/score books:** Those in attendance agreed having a yearbook as opposed to score books by team is better. Amie proposed we presell the books prior to having printed so we don't throw so many away, if not purchased later. We should start these soon but they will not be done by the time the compulsory girls start meets in September. Christi said she cannot schedule team photos until she knows when competition wear will be ready. So it may not be until December/January when books will be ready. The printer we've used in the past retired so we need to find a printer who is willing to donate the printing.

**Peaches:** Kristin McWilliams said IGBC made about \$2800 from peach fundraiser. She will compile information to hand off for person who will run fundraiser next year so her gymnast is a senior.

**SCRIP**: Kristin will send out information again. It's a great opportunity for individual gymnast families to earn money as 25% goes to IGBC and 75% goes directly toward gymnast account.

>>> Need someone to take over when for Kristin, preferably work with her a few months before she leaves next spring

Also discuss, distributing funds of boy gymnast who's sister is on Xcel since he left and his funds were unused during Covid. It's about \$88. Board unanimously voted yes since it is a sibling relationship.

to be in big group to be able to make most money we need at least 125 checkins receive \$20/ticket (tickets are \$30 includes wine tasting, lunch, raffle tickets) then big prize money gets distributed among organizations

>>>need 5 volunteers day of event (or 10 so can split into 1.5 hour shifts)

if not at least 125 checkins or volunteer doesn't show up we don't get money tickets available now

this week until 9/10 org that has highest ticket sales this week wins \$500 bonus send out email blast and make sure they choose Incline and put gymnast name in
